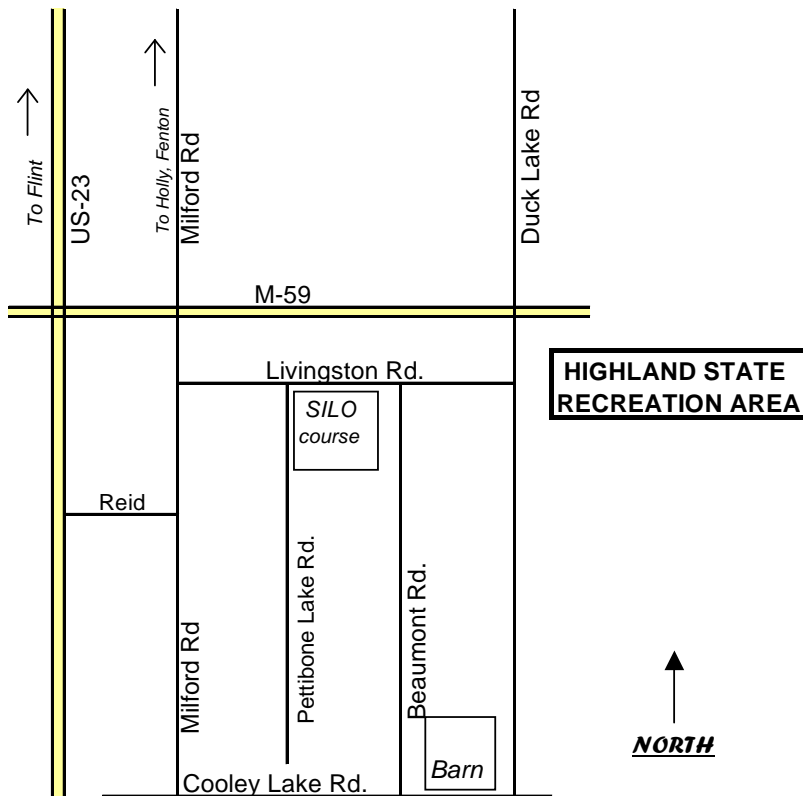
DIRECTIONS TO THE GROUNDS

Highland Recreation Area, Silo Course, is located on Livingston Road between Pettibone Lake Rd. and Beaumont Rd. Livingston Road is south of M-59, running East/West between Milford Rd. & Duck Lake Rd.

NOTE: A Michigan State Park permit is required for every Motor Vehicle to park on the grounds. Permits may be bought at the grounds.

There is no indoor shelter nor indoor restrooms. A camping fee of \$12.00 per night will be charged by the Highland Field Trial Grounds Association, collected by NGSCM.
